

Emergent 2023: Graduate Showcase

Terms and Conditions of entry

All entrants must read the terms and conditions below prior to submitting an entry.

1. Entry to *Emergent 2023: Graduate Showcase* is FREE and open to young people who live, study or work in the City of Casey, or have a significant connection to the City of Casey (i.e. participation in a sporting team, dance school, family etc.)

2. Submissions to Emergent 2023: Graduate Showcase – Performance will be judged according to areas of study:
 - (i) VCE Drama
 - (ii) VCE Theatre Studies
 - (iii) VCE Dance
 - (iv) VCE VET dance
 - (v) VCE Music Style and Composition
 - (vi) VCE Music Performance
 - (vii) VCE Music Investigation
 - (viii) VCE VET Music Industry (Performance)
 - (ix) VCE VET Music Industry (Sound Production)
 - (x) VCE Extended Investigation
 - (xi) International Baccalaureate Dance, Music or Theatre.

3. Submissions to Emergent 2023: Graduate Showcase – Exhibition will be judged according to areas of study:
 - (xii) Units 3 & 4 Art Making and Exhibiting
 - (xiii) Units 3 & 4 Art and Creative Practice
 - (xiv) Units 3 & 4 Media
 - (xv) Units 3 & 4 Visual Communication and Design
 - (xvi) Units 3 & 4 Product Design and Technology Woodwork
 - (xvii) Units 3 & 4 Product Design and Technology Textiles
 - (xviii) Units 3 & 4 Theatre Studies (Set design, Costume Design or Props)
 - (xix) final year of VET Certificate II Applied Fashion Design and Technology
 - (xx) final year of VET Certificate II Screen and Media
 - (xxi) final year of VET Certificate II Visual Art
 - (xxii) VCEVM Art
 - (xxiii) International Baccalaureate Arts

4. A maximum of one submission per subject per person will be accepted (i.e. you can submit one application for Art and Creative Practice and one application for Media if you study units 3&4 of both subjects, or, submit one application for VCE Music Performance and one application for Theatre Studies if you study units 3&4 of both subjects).
5. All visual art, photography and design entries must be accompanied by at least three photos. The complete body of work must be represented in the entry. (For example: a photo series would require an image of the complete photo series; digital files must include the entirety of the piece; installation must include images of each part of the installation) Entries will be judged by a panel of Creative Industry professionals. The judges' decision is final; no correspondence will be entered into.
6. All video/film and performance entries must be accompanied by a recording that presents the video/film or performance in full.
7. Submission of work to this competition does not guarantee work will be exhibited or showcased.
8. Accepted artwork/pieces/performances will be notified via email.
9. Closing date for applications is 11.59pm 8 October 2023. Unfortunately, late applications cannot be received.
10. Entries will be judged by a panel of Creative Industry professionals. The judges' decision is final; no correspondence will be entered into.
11. Accepted performances will be featured in the Emergent 2023 Graduate Showcase: Performance on Sunday 17 March 2024.
12. Emergent 2023 Graduate Showcase: Performance participants will enter into a Performance Agreement with the Bunjil Place.
13. Accepted artwork, performances and artists may be shown in local newspapers and in City of Casey publications, including hard copy and electronic formats.

14. Artwork, design, photography, film and projects accepted into Emergent 2023 Graduate Showcase: Exhibition will be on display at Bunjil Place Studio from 17 March – 7 April 2024. Work must be available to exhibit for the full duration of the exhibition. If your work is not available for the full duration of the exhibition, then you are unable to participate in the show.
15. Performing Arts participants must be available for the Emergent 2023 Graduate Showcase: Performance on Sunday 17 March 2024, all rehearsal times including tech and dress runs.
16. If you are successful in your application to participate in the exhibition, original work must be provided. No copies or reproductions of your work will be exhibited. (video work is the exception to this – exhibition copies will be accepted).
17. The City of Casey will make all efforts to ensure the safety of the work submitted to the competition; however, no responsibility is taken for lost or damaged artworks.
18. Arrangements must be made to collect all artwork no later than 8 April 2024 (unless alternative arrangement has been made). Bunjil Place Gallery will notify you of the work collection point. Any work not collected by this date will be destroyed.
